RULES OF THE "EUROPEAN DYSTOPIA" CONTEST.

Article 1 - Organiser

This competition is brought to you by European Citizen Action Service (hereinafter, the "organiser"), whose registered office is located at Rue Cantersteen 12, 1000 Brussels, Belgium. Article 2 - Duration and conditions of the competition

2.1 Duration:

Participation in this competition is open on the ECAS Crowdsourcing Platform "European Dystopia" page (<u>https://crowdsourcing.ecas.org/en/Dystopia</u>) from 18 July 2023 11:00 am CET to 30 November 2023 11:59 pm CET (Belgian connection dates and times being taken as proof).

2.2 Conditions of access to the competition:

The competition is open to all natural persons of legal age, except for staff members of the European Citizen Action Service and the partners implementing the European Dystopia for sessions activity. Each natural person (online via the ECAS Crowdsourcing Platform) may participate only once. If several entries are detected, only the first one will be considered a valid entry. Participation in the competition is free of charge.

Article 3 - Terms and conditions of the competition
